K-State Federal Credit Union Check Card Agreement

In consideration of the receipt of a Kansas State University Federal Credit Union (KSUFUCU) Check Card and the privileges to which the holder thereof is entitled, Cardholder hereby agrees to the following terms and conditions as to the use of said card.

- The card and its coding is and remains the property of KSUFUCU, and the Cardholder agrees to surrender said Card to KSUFUCU immediately upon request or when Cardholder closes or otherwise changes the status of Account(s) in KSUFUCU. KSUFUCU reserves the right to cancel and/or modify any or all Cardholder privileges, without notice.
- Cardholder agrees to use this Card as instructed and only for purposes authorized by KSUFUCU. Transactions may be initiated against Cardholder's Account(s) by the combined use of Card and personal identification number (PIN), or by presentation to an authorized VISA Merchant. Cardholder agrees not to authorize or permit any other person to use the Card. Cardholder will not disclose the PIN to anyone, nor otherwise record it on the card. Cardholder agrees that in any event, except as specifically provided in paragraph (c) below, all transactions made to Cardholder's Account(s) by KSUFUCU as a result of the use of this Card (or by the use of a card issued to any other party who is named as joint owner of the affected account) shall be fully binding on Cardholder, and KSUFUCU is authorized and directed to credit and charge, as the case may be, all deposits, withdrawals, borrowings, and transfers to or from Cardholder's Account(s) and to accept all payments on Cardholder's indebtedness as, when and by whomever made with the card through the use of the machine, without further inquiry.
- Cardholder will notify KSUFUCU at once if the Card is lost or stolen or if statement of Account(s) contains any unauthorized deposits, withdrawals, borrowings, or transfers. Cardholder agrees to hold KSUFUCU harmless for any claim or demand arising from loss, theft, or unauthorized use of the Card except as outlined in the KSUFUCU current Disclosure Statement.
- All deposits and payments shall be subject to verification. In receiving items for deposit, KSUFUCU acts only as a collecting institution as defined in the Uniform Commercial Code. KSUFUCU deposits and collections, and the responsibility of the KSUFUCU and the mutual rights and obligations of Cardholder and the KSUFUCU shall be governed by the general provisions of the Uniform Commercial Code-- Deposits and Collections, and by all other applicable laws, rules, regulations and agreements governing Cardholder's Account(s).
- Cardholder agrees to examine all transaction receipts promptly and to notify KSUFUCU of any error immediately.
- KSUFUCU provides this facility to Cardholder as a financial service; however, it is possible this service facility may not function properly at all times. KSUFUCU makes no claims or warranties in respect thereto and shall not be responsible or liable if the facility at any time should fail to function properly.
